ITEM 1 - OPENING REMARKS

ITEM 3 - MATTERS ARISING FROM THE PROCEEDINGS OF THE PREVIOUS MEETING

- 3. The following matters were raised:
 - a. **Generic Recruiting Material.** Recruiting material which can be adapted for individuals is now available on SapperCom.

- b. **Standardised Presentation.** A standardised presentation is not to be made available. REA members are requested to "book" a presentation which would be delivered by the Ops Director.
- c. **Membership**. The new types of membership have been added to the REA Rules.

ITEM 5 - DISCUSSION MISSION ACTIVATE

- 10. Currently branches are able to claim up to 2 x Mission Activate payments of £250 every year (April to April) and then a further £25 per person recruited from the event. The scheme is being abused by some branches who are using to subside events which have no intention of recruiting as well as rewarding what should be routine behaviour i.e. recruiting people who would ordinarily become a member. The following options for reforming Mission Active were discussed:
 - a. No Change
 - b. 1 x event payment per year to a branch on application. Discontinue the bounty.
 - c. Option 3 finish the scheme

After much discussion it was decided that grants should be allocated to events in general and (not specific recruiting events) as the way to encourage membership and participation in the REA. The outcome of an online discussion will be discussed and published in the minutes of the next recruiting committee meeting.

ITEM 6 – DISCUSSION RELATIONSHIP BETWEEN GP DIRECTORS, DEPUTY GP DIRECTORS, GP SECRETARIES

- 11. The Issue: Relationship(s) between Group Directors, Deputy Gorup Directors and Secretaries varies, resulting in inconsistent outputs.
 - a. After gathering the opinions from the committee members' attendees it was established that the link between Group Directors and Secretaries is inconsistent with some Directors and Secretaries not being aware of their role in the REA. What is effective is when there is a routine dialogue between the Director, Deputy and Secretary. **Action: HQREA to write to all Group Directors and Secretaries to outline their role.**

ITEM 7 - DISCUSSION: MERGER OF SOUTHERN AND SOUTH EASTERN GROUP

It was agreed by the committee that the branches which currently sit in the Southern Group will move to the South Eastern Group. 36 Engr Regt will become responsible for the National branches. This will mitigate any disruption caused by the move of 36 Engineer Regiment.

- Fundraising. A meeting on how best the REA and its members could fundraise for the 13. Sapper Charity will be held at a date tbc.
- 14. Recruitment Posters. MP shared posters which he has been working on. The committee

commented on the posters. MR	P will incorporate the comments into future iterations.
